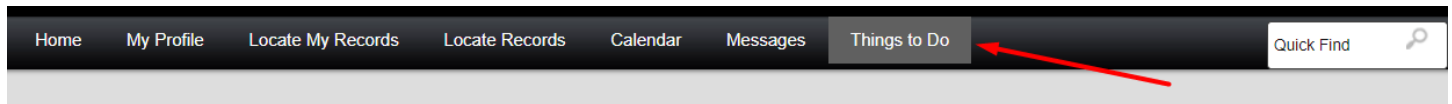


Protocol Violation - PI Guidance for reviewing a PV submitted on their behalf

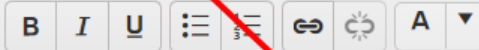
